### Divorce Education Seminar

**Grayson, Fannin & Cooke Counties**

The Kids Hurt Too Divorce Education Seminar started in 1997 in Grayson County due to the District Judges' heartfelt concern for the well being of children of divorce. Since that time thousands of parents have attended the seminar. In 2003, the program expanded to the 6th Judicial District Court and 336th Judicial District Court in Fannin County, and as of July, 2008 the 235th Judicial District Court of Cooke County filed a standing order for the program. In the fall of 2008, the 397th Judicial District Court was added to Grayson County. The seminars are facilitated by licensed mental health professionals.

The standing order for all three counties reads, in part: *the parties are ordered to successfully complete said seminar within sixty (60) days of either the filing of the petition or motion to modify or the receipt of notice of the petition or motion, and prior to any final hearing.*

It is our privilege to work with the district court judges in Texoma to help divorcing parents understand the impact divorce has on their children and how they can avoid placing their children in the middle.
